

# **Distributions Continue to Rise**

Once again, despite less than favorable market conditions, the Foundation is reporting the highest distribution total in its history. Over \$1.1 million was available for distribution to our beneficiaries in September of 2008. How is this possible? Distributions are based on a 12 quarter rolling average of the value of the individual endowments. By following this policy, the Foundation has been able to set aside funds in times of plenty to ensure distributions in more challenging market conditions. The Foundation's portfolio is constantly being evaluated to maximize returns, while being ever aware of Church teachings in our investment strategy.



# **Investing in Education**

Forty Martyrs parish in Tuscola decided to start a new endowment. A previous endowment had been established specifically for college scholarships, but the parish wanted

to do more. When a bequest was left to Forty Martyrs in memory of Fr. James Casey, it was decided to create a new endowment. This would also be for scholarships, but the language of the agreement allowed for scholarships other than college related ones. When asked to comment on the new scholarship Fr. Barry Harmon said, "I am grateful to the Foundation for allowing us to help our young people further their educations and continue to follow the call that God has given them." To date, 49 Forty Martyrs parishioners have been awarded scholarships.


